

## 2022-23 School and Holiday Camps Terms & Conditions

**Payments:** For 5-day camps, you may pay in full or pay a **\$50 non-refundable deposit** to reserve a spot for your child. **If you pay a deposit by credit card, your card will automatically be charged the balance due Friday before the corresponding week of camp.** If you register for more than one week of the same camp the \$50 deposit will be applied to the last week of registered camp.

**Cancellation / Refunds:** Cancellations must be made 72 hours prior to the start of the camp. If you paid in full at registration and cancel before the 72 hours preceding camp, monetary refunds will require a 25% admin fee before processing (refund excludes the \$50 deposit). To avoid the admin fee, funds can be transferred to your Chaparral Ice account for future use.

**Availability:** Space is limited and is first come, first serve. Chaparral Ice reserves the right to cancel or close any camp sessions. Chaparral will notify paid participants of any cancellations ahead of time, if possible. **The registration deadline is Friday before each week of camp at 8:00 AM, or until the capacity has been met.**

**Sign-in / Sign-out Procedures:** Drop-off times for Regular Programmed day- 8:00-9:00 AM, Pick-up times 5:00-6:00 PM. For your child's safety, we require parents to sign their child in every morning at drop-off and sign them out in the afternoon at pick-up. **Only authorized persons listed on your child's registration form**, including the parents/guardians listed as well as the emergency contact, will be allowed to sign your child out. Please allow a few extra minutes for signing in/out. **The authorized pick-up person or guardian must present a valid photo ID in order to retrieve their child.**

**Late Pick-ups:** Your child must be picked up by 6:00 PM. You will be charged **\$1 per minute after 6:00 pm**, payable immediately. After 3 late pick-ups, the fee increases to \$5 per minute. Your late fees must be paid before your child can return to camp.

**Participation:** By signing this form you agree that your child is physically, mentally, and emotionally able and has your permission to participate in all camp activities unless camp staff is informed otherwise. Participation in camp activities will enhance your child's camp experience.

**Transportation:** If applicable, I authorize my child to travel to/from camp activities in the Chaparral Ice van, bus or other transportation arranged by Chaparral Ice.

**Discipline:** Please encourage your child to follow the instructions of camp counselors and Chaparral Ice staff. Behavior problems may result in a meeting with the Camp Director and a consultation with the parents. Chaparral Ice, at its sole discretion, reserves the right to expel any child from camp if negative behavior endangers the health, safety, or well-being of another person, including themselves. We cannot be responsible for children who will not cooperate or follow instructions. There will be no refunds for children who are expelled for disciplinary reasons.

**Accidents:** In case of sickness or accident, Chaparral Ice has my approval to secure, at my expense, such medical attention as deemed necessary, if unable to contact me.

**Medication/Illness:** Any medication to be administered to campers must: (1) be given directly to a camp counselor or the Camp Director at sign-in; (2) be in the original container with its original label; (3) and parents must fill out the medical authorization log. All medication will be kept in the camp office.

\*Parents please note: Although we will make every attempt to give the medicine on time, it is ultimately the camper's responsibility to notify the camp staff when the medication is to be taken. If the medicine is to go home with the camper daily, it is the responsibility of the parent to sign it out from the camp office.

**Special Needs:** The Camp Director should be notified if your child has special emotional or physical needs. We will make every effort to serve campers who have special needs, however, we will not accept campers who have needs beyond our training or capabilities.

**Liability:** At all times the camper shall be liable for personal injury and/or property damage or loss incurred while on the premises or while in the care of Chaparral Ice employees and the camper agrees to defend and hold Chaparral Ice Center, its officers, agents and employees harmless against any and all liability for claims, demands and causes of camper's use, maintenance and operation of the facilities or otherwise upon the premises or from the camper's negligence during the term of this agreement.

**Acknowledgment of Covid-19 Risks:** I understand that an outbreak of the Covid-19 virus has occurred in the United States and that the virus is novel and may cause known, unknown, foreseen, and unforeseeable risks. I understand that the virus poses health risks to those who contract it and to those who come into contact with individuals who have contracted it. I understand that the virus may pose a higher risk to certain individuals such as those who are immunocompromised, have chronic medical conditions, are pregnant, and in older adults. I understand that the virus may cause illness and symptoms including fever, cough, shortness of breath, mild to severe respiratory illness, and death. I understand that childcare facilities are currently allowed to continue to operate during the COVID-19 outbreak, but that the virus is highly contagious and cannot be eliminated from the childcare environment. I certify that I am the parent and/or legal guardian of the above-named child, that I accept and agree to be bound by the requirements for continued childcare above and give permission for my child to continue to participate in childcare with the childcare provider and at the facility stated above. I release all and hold the Chaparral Ice harmless of all claims that may arise out of or in connection with this Consent and Agreement to Continue Childcare and/or related in any way to COVID- 19.
